

Meeting Minutes May 2007

The monthly meeting of the Christian Youth Rodeo Association was called to order by Adult President Wayne Whiting at 7:25 p.m. on May 9, 2007 at the Citizen's State Bank in Paola, Kansas.

Youth Secretary Ali McKiearnan read the minutes from the April meeting. Minutes were approved as read.

The Saddle Club has approved we re-schedule the rained out May 6th rodeo for June 29th. Delbert told Wayne he is good w/being there 3 days. Dave moves we have the rodeo on June 29th at Burlingame, motion passed.

Dave moves to allow contestants that may not have entered originally for the Burlingame rodeo, be allowed to enter. Contestants that were entered but now cannot come, will be allowed to draw out w/no penalty. Motion passed.

Wayne reports there was miscommunication between us and the Lyndon Saddle Club. Wayne told Connie Wright from the Lyndon Saddle Club that we had August 11th and 12th as pending dates at Ottawa. If Lyndon would like for us to come there, instead of Ottawa on those dates, we would do that, otherwise we would push Lyndon back to the fall.

2007 Finals options are Mound City and Ottawa on August 24, 25, and 26. Adult Board Member Jeff Smith said he would contact John Teagarden about Mound City arena charges.

Dave gave back the ½ and ½ ticket money he won in the last drawing. He is asking the association to set up a Cowboy Church account w/that money. The money could be spent to give a donation to the visiting speakers.

Wayne report Event Directors are not going as planned. There have not been many volunteers. It was decided the event will not start until at least the adult event director is in the arena.

Dave moved to adjourn at 8:44 p.m., all were in favor, motion passed, meeting adjourned.
