

## Christian Youth Rodeo Association

In this packet you will find the required form(s) for membership in CYRA. Please check and re-check all signature requirements (notary requirements) and information areas needing to be completed.

- Parents, please make sure your signature is readable. Please print your name under your signature, if needed.
- A copy of your birth certificate (new members only!) is required
- A copy of proof of enrollment (grades 9-12) is required. If you are home schooled, a letter from whomever you report your grades to will be accepted.
- Membership fee for the 2010 season is \$70 per member. A family of 3 members or more is \$70 for the first two members, ½ price for each additional member. (this is for sibling groups only)
- Membership forms are required to be filled out completely and returned to the association secretary as soon as possible, prior to entering your first rodeo. You must call into the first rodeo.
- No entries left on an answering machine will be accepted.

An incomplete application WILL NOT be accepted and may compromise your entry for the first rodeo. Entries will not be accepted until all paperwork is in the office of the association secretary.

In this packet you will also find a sponsorship form. Requirements for the amount of money needed to qualify for the 2011 finals, has changed. This year each member must bring in \$100.00 in sponsorship money to the association. Money must be turned into the association treasurer by May 1, 2011.

At each rodeo we will sell ½ and ½ tickets to help support the college scholarship fund. Half of the money goes into the fund, the other half goes to the drawing winner.

At all 2 day rodeos, Cowboy Church will be held on Sunday morning at 8:30 a.m.

## Responsibility Agreement

As a CYRA member, it is your responsibility to meet the requirements of the association to be a member in good standing. In order to qualify for finals or receive year and awards, a member must be in good standing with the association before being allowed to enter the finals or receive year end awards.

To be a member in good standing, all CYRA members must:

- Present a notarized application, grade card of proof of school enrollment (grades 9-12), and birth certificate (new members only) when paying membership for the new rodeo season. Members/contestants will not be allowed to participate in any CYRA sanctioned rodeo until all required documents are received.
- Any fund raiser money must be turned in to the designated board member or committee chair appointed by the board.
- Must be a paid member who had entered and competed in at least 1/3 of the total number of rodeos for that season in their qualifying event.

As parents of the CYRA member, you agree to be financially responsible for this mandatory requirement.
